If you want to contact a member about an individual case with the exception of the members who are Judicial Officers, please do so at the member's office where they can access the necessary information to assist you. Thank you in advance for respecting the need to keep the discussions focused and for your courtesy in recognizing that members should be contacted at their own offices about matters outside the DVOMB meeting agendas.
