If you want to contact a member about an individual case with the exception of the members who are Judicial Officers, please do so at the member's office where they can access the necessary information to assist you. Thank you in advance for respecting the need to keep the discussions focused and for your courtesy in recognizing that members should be contacted at their own offices about matters outside the SOMB meeting agendas.

**Anti-Harassment and Discrimination Conduct:** The Office of Domestic Violence and Sex Offender Management, believes that an equitable, diverse, and inclusive workplace is one where all employees and community partners, whatever their gender, race, ethnicity, religion, national origin, age, sexual orientation, gender identity, citizenship status, education, disability, socio-economic status, or any other identity, feel valued and respected.
