Action Items & Solicitation for Public Comment

The Board reviewed the following Action Items during the August Board Meeting.

- 1. Revisions to Juvenile Standard Section 10 and Appendix K Additional Conditions of Community Supervision. These revisions were reviewed by the Board and sent back to committee for revisions and returned to the committee for further revision.
- 2. Revisions to Juvenile Standard Section 2.210 Pre-Plea Evaluations. These revisions were reviewed by the Board. The Board made an additional suggested revision that was voted on to be approved to be sent out for public comment along with the original revisions.
- 3. Revisions to both the Adult and Juveniles Standards Section 4: Qualifications for Polygraph Examiners. The Board made additional revisions to the original document and it was approved to be released for Public Comment.
