SB 22-150 Report requirement (Link to SB 22-150)

C.R.S 24-33.5-2605(2)(a) On or before December 31, 2023, and on or before December 31 of each year thereafter, the department shall submit a report on missing or murdered indigenous relatives to the House of Representatives Judiciary Committee and the Senate Judiciary Committee, or their successor Committees, and the Governor's Office. The department shall make the report available to the public on its website. The report must include an update about missing or murdered indigenous relatives in Colorado, including the information included in the dashboard described in subsection (1) of this section; the recommendations for legislative and governmental agency actions described in section 24-33.5-2602 and any other recommendations to address injustice in the criminal justice system's response to the cases of missing or murdered indigenous relatives; and a summary of the office's work during the year

Data related to Colorado MMIR - 24-33.5-2605. Informational dashboard

On November 1, 2023 the Colorado Bureau of Investigation (CBI) and the Division of Criminal Justice (DCJ), within the Colorado Department of Public Safety, officially launched the Missing and Murdered Indigenous Relatives dashboard established by SB 22-150. This publicly available dashboard is updated automatically whenever new cases are reported or there are updates to individuals already reflected in the data.

Summary of the Office's work during 2024

The Office of the Liaison for Missing and Murdered Indigenous Relatives (OMMIR) within the <u>Colorado Division of Criminal Justice</u> (DCJ) are working collaboratively with the Indigenous communities and other Tribal, local, state and federal government agencies to enact legislative mandates and improve outcomes for those impacted by MMIR. This is a summary of pivotal highlights of some of the work completed during the 2024 calendar year:

- The OMMIR received a new Director, Melody Delmar, in April this year. A national search was conducted after extensive engagement with community members, stakeholders, and state entities. A shared vision was established between the office and community, resulting in the selection of Melody Delmar. Ms. Delmar leads the office with a wealth of experience in MMIR work.
- The OMMIR met with Colorado Peace Officers Standards & Training (POST) trainer about the mandated MMIR Training (C.R.S. 24-31-315) in April, and is working collaboratively to currently review and update along with subject matter experts in law enforcement who work in Native American communities that are experienced with MMIR.
 - This training has been implemented and incorporated into the curriculum within Colorado POST certified academies for new certified peace officers and at in-service training for veteran certified peace officers.
- The office continues to grow with the addition of our Community Support Coordinator, Shay Arcella-Bohman, who is of the Shawnee Tribe and Cherokee Nation. Her role within OMMIR is to engage with families, community members, stakeholders, and public safety entities. Her role will focus on continuing to build networks, partnerships, education and awareness of MMIR in Colorado.
- Established National partnerships with the United States Attorney Generals Office, the Federal Bureau of Investigations, and emerging Missing and Murdered Indigenous Persons initiatives.
- Initiated and hosted the first interstate convening of MMIR law enforcement response including Tribal and state law enforcement, state Tribal liaisons, and Attorney General's offices. Various groups represented were:

Synopsis of the Topics Covered During Community Volunteer Advisory Board 2024 Meetings

As required by Colorado General Assembly Bill SB23-054 the Community Advisory Board for the Office of Missing and Murdered Indigenous Relatives has created a general report of the meetings that have occurred for this year. In this effort, the following is a synopsis of the meetings.

Community Volunteer Advisory Board meetings strategically included guest speakers and experts covering topics related to Indigenous communities, closing the gap between law enforcement agencies and Indigenous people, raising awareness, how to report a missing person and additional subjects related to OMMIR.

February 2024 Community Advisory Board Meeting

Summary: This meeting covered the hiring process of the new Director for the office. Director Matt Lunn introduced the news Community Advisory Board Member Lynnette Greybull. Maria Trujillo, Human Trafficking Manager within the Office of Victims Programs, gave a presentation on the Colorado Human Trafficking Council and Q&A. CCIA introduced a calendar. Report preparation was discussed and a subcommittee was recommended. Requests for law enforcement training, specific to native communities, and updates on upcoming meetings.

May 2024 Community Advisory Board meeting

Summary: The new OMMIR Director Melody Delmar was both introduced and welcomed by Director Matt Lunn. Community members gave their own introductions to the new Director. Adrienne Perkins, OMMIR Program Assistant, announced her departure from the office. Director Delmar gave a brief overview of an outline of focusing on community partnerships and getting to know the Tribes, communities across the state.

July 2024 Community Advisory Board meeting

Summary: DCJ Director Matt Lunn gave updates on the ongoing DCJ strategic planning pillars to build out objectives and measurables that fit with the work of the Community Advisory Board and the work of OMMIR. Newly appointed DCJ Deputy Director Chris Lobanov-Rostovsky introduced himself to the meeting and future engagement with the OMMIR and community advisory board. Director Delmar highlighted updates on continued work on building partnerships and collaborations across the state and building staffing capacity within OMMIR. Community partners, advisory board members, and attendees were able to engage with open networking and discussion on trainings, resources, and working with diverse tribal community populations across the state.

2024 OMMIR Interactive Dashboard

The <u>OMMIR Interactive Dashboard</u> is in collaboration with Colorado Bureau of Investigations (CBI). The multifunctional dashboard contributes to raising awareness by reaching a universal audience and providing additional resources to support families, community members of missing relatives. The dashboard went live on November 1, 2023.

2024 OMMIR Resource Line

The resource line, established by SB 23-054, and partnership with the Colorado Division of Homeland Security and Emergency Management resource line launched November 1, 2023, in conjunction with the dashboard.

The resource line, established by <u>SB 23-054</u>, was developed and is staffed by the Colorado Division of Homeland Security and Emergency Management. The team is trained to receive and refer calls from the public. The dedicated phone line for missing or murdered Indigenous relatives, operates 24 hours a day, 7 days a week, and connects callers with the appropriate local law enforcement contact or the Office of Liaison for Missing and Murdered Indigenous Relatives.
