Take the sting out of Standards Revisions by BEEing Informed.

This bulletin is to keep providers and stakeholders informed about Board Business and changes happening that affect their daily practice.

### Pending Standards Revisions

The Board reviewed the following Action Items during the April Board Meeting.

1. Revisions to Section 3: Standards of Practice for Treatment Providers within the Adult Standards and Guidelines. 3.160: Core Treatment Concepts. The Board voted to send the proposed revisions out for public comment.
2. Revisions to Appendix E: Sex History Decision Aid for the Adult Standards and Juvenile Standards, and Guidelines. These revisions are to the Introduction to each section, following changes to the existing statutory language. The Board voted to send these proposed changes to Public Comment.

### Public Comment

Public comments will be collected electronically via Jotform. The Jotform will be available on April 28th, and public comments will be accepted until May 9th, 2025. Comments will then be reviewed by the appropriate standards revisions committee and the Best Practices Committee.

The following Revisions are currently in the Implementation Phase and should be fully implemented by July 1, 2025
