This bulletin is to keep providers and stakeholders informed about Board Business and changes happening that affect their daily practice.

Pending Standards Revisions

The Board Reviewed the Following Action Items:

1. Adult and Juvenile Standards: Appendix B - Guidance Regarding Victim/Family Member Readiness for Contact, Clarification, or Reunification. The proposed revisions to Appendix B offer a more responsive framework for MDTs/CSTs, focusing on the nuanced needs of victim contact, clarification, and reunification as a part of sex offense-specific treatment. This update addresses feedback that the prior version functioned too rigidly as a victim readiness checklist. The Board approved this item and voted to release it for public comment.

The Board Reviewed the Following Decision Items:

1. Adult Standards Revisions: Appendix I-Notice of Discharge Status Form and Public Comment
2. Treatment Modifications Request Process and Jotform. The Board has approved this process, and guidance to the field will be forthcoming.

Public Comment

Public comments will be collected electronically via Jotform. The Jotform will be available on October 27th, 2025, and public comments will be accepted until November 7th, 2025. Comments will then be reviewed by the appropriate standards revisions committee and the Best Practices Committee.

Standards Revisions Approved by the Board
